

# Borough, county, Unitary authority and Editions Selector

This Selector should help you choose the Editions and areas for which you wish to sponsor or cobrand the 500 or 1000 free issue licenses.

The minumum number of free licenses you can cobrand as shown in the SunLife example above is 500. The minimum fee for cobranding and issue of cobranded licenses to selected end users is £1.20 per license. You will need to bid higher than £1.20 for premium areas, such as City of London, Westminster, Lambeth etc. You should provide us with the artwork for the logo for cobranding as well as the website link that you wish to embed within our App. Please use the Purchase Order template provided below to order.

#### **Editions**

There will be 5 Editions aimed at the following market segments that you could embed in 2025-26

Each edition will be announced to existing embedding and cobranding customers and will be open for booking for up to 30 days, with 7 days of grace.
